The purpose of the proposed rules and amendments is to implement requirements under the Federal Clean Air Act. The proposed rules will adopt changes to the ambient air quality standards, the New Source Performance Standards, Prevention of Significant Deterioration (PSD) requirements, Title V Permit to Operate rules, the National Emission Standards for Hazardous Air Pollutants for source categories and Permit to Construct rules. Other minor technical corrections to the rules are proposed. The rule changes are expected to have an impact on the regulated community in excess of fifty thousand dollars.
