This rule establishes parameters and personnel requirements for ongoing activities programs, social services, chaplain services, and mail. The proposed amendments clarify the need for private visitation spaces, resident access to telephone services, and pet policy requirements. Proposed amendments also address computers, electronic mail, and cellular phones.
