- 5. **LISA LaFONTAINE**, who was nominated by the Mayor on September 17, 2012, and was deemed approved by the Council pursuant to Proposed Resolution 19-0987 on November 4, 2012, is appointed to the Board, as a consumer member, for a term to end April 16, 2015.

- 6. **DR. JULIE GARNIER** is designated as Chairperson of the Board and shall serve in that capacity at the pleasure of the Mayor.
