This rule sets general requirements for enclosures that apply to all dangerous wild animals. Rules 901:1-4-02 to 09 set forth specific size, height, building material, and other related provisions for individual species or groups of species. Set forth in this rule are the building standards for primary enclosures, cantilevers, safety entrances, shift cages, secondary enclosures, temperature, ventilation, and lighting. Some facilities will already have many, if not most, of these features in place and will not need to build from the ground up. Additionally, the rule has been written to be outcome oriented as much as possible, and allow for flexibility in construction materials and technique. In the Business Impact Analysis it is calculated that fencing materials alone for a primary enclosure for a bear would cost approximately \$1400. In the example of the bear, a total cost of approximately \$5000 could be possible if an owner has no existing enclosure onsite. It is anticipated that the majority, if not all, of the current owners of dangerous wild animals already have some type of enclosure.

To further control costs, not all species regulated by this chapter require all enclosure features. Dig barriers, shift cages, and safety entrances are not required for certain species where appropriate. With input from the stakeholders, the Department significantly revised the rules to create greater flexibility while also

ensuring the appropriate public safety. While the Department does acknowledge there will be costs imposed by these standards, the Department is statutorily required to adopt these rules by the General Assembly in R.C. § 935.17 which protect public safety and the health and safety of the regulated animals.
