This rule sets standards for care and well-being that are specific to hippopotamus, elephants, rhinoceros, and cape buffalo. The rule includes species specific requirements for enclosure height, size, and features.

This rule requires differing enclosure sizes depending on the type of animal being housed, ranging from a minimum of a seven hundred square foot enclosure for a cape buffalo to a four thousand square foot enclosure for some elephants. Enclosures are to be constructed of steel bars, masonry block, rock walls, or equivalent materials. The cost of compliance with this rule can vary greatly depending on the existence and condition of an existing enclosure, the physical location of the enclosure, and the manner in which the enclosure is built.

If an existing enclosure already meets or exceeds the standards of this rule, an owner will likely incur little to no additional expense. Some enclosures may need to be expanded or modified, but the degree to which modification is needed will depend on how close the existing enclosure conforms to these standards. Some owners may be required to build new enclosures if they lack an existing enclosure or a current structure is incapable of being modified to conform to these rules. The cost of compliance will be highest for these owners.

Due to the variability in building material choices, an accurate estimate for

enclosures related to the large mammals covered under this rule is difficult. A seven hundred square foot enclosure constructed from masonry block would cost approximately \$7500 for all building materials but excluding labor costs. A two thousand square foot masonry block enclosure, sufficient for one female elephant, would cost approximately \$21,500 in materials. However, these estimates will vary greatly based on an owner's choice of building material, construction techniques, and geographic location. Owners have a number of options when building enclosures for these types of animals, and the Department has opted to allow as much flexibility as possible that takes into account public safety and animal welfare.
