Most parts of the rule will have little or no cost of compliance. Owners transporting animals are already required to follow all applicable federal and international regulations while transporting animals, and to have certificates of veterinary inspection with the animal at all times during transport. The rule also sets times and standards for food, water, and the number of animals that can be transported together. The provisions are to provide a framework for proper care while away from the routine of the home environment.

The transport vehicle and containment is an area in which the animal owner may incur some cost of compliance. Owners may need to make modifications to existing transport systems, but it is likely that most conveyances will already meet the standards in this rule. In any case, transport of animals is a time of increased risk to the public, and a increased cost of compliance is balanced by the requirement to protect the public during transport.
