The primary cost of compliance for this rule will be the requirement that current high volume breeders bring their housing facilities up to the proposed standards, if their facilities do not already meet or exceed the proposed standards. Expanding housing facilities to meet the proposed minimum floor space requirements will have an impact on the high volume breeders. As detailed in the CSI Business Impact Analysis, he rules require a minimum space for each dog, as well as a doubling of that minimum for the first dog in each enclosure. Currently, USDA requirements for an eighteen inch dog are four square feet per dog and no exercise outside of the enclosure is required for enclosures eight square feet in size or larger. The proposed rules, for the same size dog, require an initial enclosure of eight square feet, and an additional four square feet per additional dog. Enclosure costs will vary due to differing materials, sizes, and features added by the breeders. An American Kennel Club licensed pro-breeder kennel from one retailer costs \$358 for a four foot by eight foot kennel, without flooring or roof. (Hooverfence.com) A smaller, four foot by four foot, kennel constructed from the same type of paneling would be approximately \$246.

This estimate does not account for the three year window in which existing enclosures may continue to be used. Input received from the breeder community indicates that most enclosures are already replaced around five years. The rules are designed to allow for existing breeders to recover as much of their capital investment in their facilities as possible. During the implementation period, all breeders will still be required to meet all health requirements, and the health of the
